## **WAIVER, RELEASE, AND HOLD HARMLESS AGREEMENT**

Pursuant to the policies and procedures of West Florida Home Education Support League ("WFHESL"), I, as the Parent/Legal Guardian of child/children listed below, hereby acknowledge and agree to the following terms and conditions on behalf of my child[ren]'s participation in the WFHESL \_\_\_\_\_ (event name) occurring from \_\_\_\_\_ (date or dates).

I understand and acknowledge that there are certain inherent risks associated with my child[ren]'s participation in the WFHESL event listed above, including but not limited to physical injury, illness, and emotional distress.

I hereby waive, release, and discharge WFHESL, its directors, officers, employees, agents, and volunteers from any and all claims, damages, liabilities, costs, or expenses, including reasonable attorneys' fees, arising out of or in connection with my child's participation in the Production. This release extends to, applies to, covers and includes all known, unknown, disclosed, unforeseen, unanticipated and unsuspected injuries, damages, losses and liabilities and the consequences thereof or statute to the contrary. Such provisions are hereby expressly waived.

It is further understood and agreed that my or my child[ren]'s participation in this WFHESL event listed above is not to be construed as an admission of liability or the assumption of any responsibility of any volunteer of WFHESL or any member of the organization or the host facility for any personal acts or omissions or those of mine or my child's.

I hereby agree on behalf of my heirs, executor, administrators and assigns to indemnify volunteers of WFHESL as well as all members, officers, agents, and servants of WFHESL, jointly and severally and hold harmless from and against any and all actions, claims, demands and liabilities, losses, damages and expenses of whatever kind or nature, including attorney fees, which may at any time be incurred by reason of my or my child's participation in the WFHESL event listed above under the control of WFHESL or a host facility.

I have reviewed this waiver and fully understand that this document limits my rights as a parent/legal guardian to bring a claim or suit against any volunteer or member of WFHESL under these certain circumstances as set forth herein and otherwise have executed this instrument with such knowledge. I have reviewed the birth date of each child listed below and they are correct as of the date of this release.

I understand that WFHESL may use my child's image, likeness, and voice in connection with the Production, and I hereby grant WFHESL permission to use my child's image, likeness, and voice for promotional purposes.

If any legal action or other proceeding is brought in connection with the activities identified in this Agreement, the prevailing Party shall be entitled to recover all attorneys' fees and all other related costs, including all attorneys' fees and all costs in determining the right to and the amount of attorneys' fees and costs, in addition to any other relief to which the Party is entitled.
